ORDER

1. The promotion of Clerks to Senior Clerks was issued vide proceedings read 2nd paper above. One among the promotees, viz Sri Balachandran P, Senior Clerk retired from service on 31/05/2019. Subsequently promotion orders of Clerks to Senior Clerks were issued vide proceedings read 3rd, 4th, 5th, and 7th papers above. But the vacancy which arose due to the retirement of Sri Balachandran P remained as such, unnoticed. The above omission was noticed later after having published the provisional seniority list of Senior Clerk read as 8th paper above.

Similarly, against the final seniority of clerks of Dept as on 01/3/2019 & 01/01/2021, Sri Sanchu BK, clerk of Gp HQ, Thiruvananthapuram and Sri Padmarajan K, clerk of Gp HQ, Kollam challenged their seniority position and Sri Sanchu BK filed OA before the Hon'ble KAT. As per the direction contained in the OA, Govt heard the concerned and based on the directions of Govt in G.O (Rt) No 405/2022/H.Edn dt 11/3/2022, the Final Seniority of Clerks as on 01.03.2019 and 01.01.2021 was amended vide this Dte proceedings read as 9th above.

2. In the circumstances, as the seniority positions of clerks have been re-assigned, in order to finalise the seniority list of clerks and to resolve the discrepancies occurred in the promotion order of Clerks to Senior Clerks, the following actions are ordered here under :-

- (a) The promotion of 01 x Senior Clerk against the vacancy occurred due to retirement of Sri Balachandran P wef 01.06.2019 is effected.

(b) Simultaneously, the promotion orders issued from Serial No 1 to 9 of paragraph 4 of proceedings read as 2nd above and proceedings read as 3rd, 4th, 5th & 7th above are revised and modified only to this extent.
