**ORDER**

1 Govt vide order read as 3<sup>rd</sup> above introduced online general transfer of State Govt employees and Govt. vide letter read as 4<sup>th</sup> above directed to implement General Transfer of this Department through online mode. Accordingly this department vide circular read as 5<sup>th</sup> above issued detailed instructions and invited applications from eligible employees for online transfer through SPARK software. The last date for forwarding application to State Level Office by Head of Office through SPARK was fixed on 18.04.2022.

2. Accordingly, 13 Junior Supdts submitted application for transfer through online. Based on the applications submitted, the report of the online transfer was generated on 25/05/2022. Out of the 13 applications, only one, the transfer application submitted by Smt Anjana J, JS of 1 (K) Bn NCC, Varkala was accepted by the system and report generated. Subsequently, she cancelled her request for transfer. So No Junior Superintendents were found eligible for transfer through online transfer under SPARK. Hence it was found that the applications of other JSs need to be processed separately.

3. SS Company, Kazhakuttam projected that the frequent change of HC is badly affecting the day to day affairs of that unit. Considering the point as well as the requirement of equipping the PLO office, the HOD has ordered to shift the Head Clerk post from SS Coy NCC to NCC Group Headquarters, Thiruvananthapuram and One JS from NCC Group Headquarters, Thiruvananthapuram to NCC Directorate, State Wing (PLO Office) vide proceedings read as 6<sup>th</sup> paper above.

4. Keeping in view of above, all applications of transfer of JS have been examined and decided to consider all cases and to accommodate such cases against the resultant vacancies arising out of promotion and retirement of employees and accordingly a provisional Online/General Transfer Promotion/Posting & Transfer - Junior Superintendent and Head Clerk of this Dte was published vide this Dte proceedings cited 7<sup>th</sup> above inviting representation if any to reach this Dte by 10/06/2022. Accordingly all the appeals received were examined and the genuine cases were accommodated and the provisional order is finalized as below.
