3. The employee who has availed FTBHG by counting military service in the scale of pay Rs 35600-75400 (Qualified) will not be eligible for Rule 28 (A) fixation of KSR Part-I and is eligible only for Rule 30 of KSR Part-I fixation.
4. The Seniority of the incumbent will be incorporated in the forth-publishing Seniority list in accordance with rule 27 of KS & SSR 1958.
