ORDER

1. As per the recommendation in the 11th Pay Revision approved vide G.O read 2nd above, 25% of the posts of Senior Superintendent will be on Higher Grade in the scale of pay of Rs.56500-118100/-. Total 07 Senior Superintendents/Manager are authorized in NCC Department and one Senior most Senior Superintendent/Manager is eligible for Ratio/Percentage based Grade Promotion. Consequent to the promotion ordered vide GO read 4th above, Sri. Sajimon M, Senior Superintendent(HG) took charge as Administrative Assistant, wef 02/06/2022(FN). While Sri. Jyothi N, Senior Superintendent availed CML for 7 days from 01/06/2022 to 07/06/2022 and granted as per proceedings read 5th above and took the charge of Accounts Officer only on 08/06/2022(FN). On account of the same, one vacancy of Senior Superintendent/Manager(HG) which arose in this department wef 02.06.2022 remained vacant till 07/06/2022.

2. As per the final seniority list of Senior Superintendent as on 10/01/2023, Smt. Leena G (PEN-385452), Manager, NCC Group Headquarters, Kozhikode is the next senior most eligible Manager for Grade promotion. At the same time, Sri. Jyothi N, Accounts Officer has claimed for Grade promotion in the cadre of Senior Superintendent wef 02/06/2022 on the ground that, though he was promoted as Accounts Officer on 02/06/2022 he had taken over the charge only on 08/06/2022, on availing of CML for the period from 02/06/2022 to 07/06/2022. The above matter has been referred to Government for clarification vide letter read 5th paper above and the same is awaited.

3. In the circumstances, having been satisfied with the conditions for the grant of Ratio Based Grade Promotion under the provisions in the G.O 2nd cited, the undersigned is pleased to grant the ratio percentage based Grade Promotion in the scale of Rs.56500-118100/- to Smt. Leena G (PEN-385452), Manager, NCC Group Headquarters, Kozhikode who is the next eligible Senior most Senior Superintendent/Manager with effect from 08/06/2022 subject to the condition that she will be reverted to the post of Senior Superintendent if Sri. Satheesh Sam Jose, Junior Superintendent (HG) is found eligible for Grade promotion on final verdict in OA No. 1818/2020 filed by Sri. Sathesh Sam Jose before the Hon'ble KAT. The matter regarding granting of Higher Grade to Smt. Leena G from 02/06/2022 will be taken subject to decision from Government.

4. The incumbent should submit an undertaking as per G.O. read 1st above.
