ORDER

1. This Directorate was issued promotion order of Sri Sahad MP, Clerk of 31 (K) Bn NCC wef 11.06.2018 and Sri Sudheer Kaliyedath, Clerk of 9 (K) Girls Bn NCC wef 13.06.2018 respectively vide proceedings read as 2nd paper above by considering the seniority list vide proceedings read as 1st paper above. An anomaly on seniority position between Sri Sahad MP, Clerk and Sri Sudheer Kaliyedath, Clerk were brought to the notice of this Office by 9 (K) Girls Bn NCC and the same has been examined and amendment orders has been issued vide proceedings read as 5th paper above. As a result, Sri. Sudheer Kaliyedath was placed above the seniority position of Sri. Sahad MP. Therefore, there is a need to amend the date of promotion of Sri Sudhir Kaliyedath and Sri Sahad MP. Hence the promotion issued vide proceedings read as 2nd paper above is here by amended as follows. Rest no change.

2. Government vide GO read as 4th paper above has ordered that considering the situation of non-conducting of departmental examinations in the context of covid-19, those applied for departmental examination in the year of January 2020 and Jan 2021 but unable to qualify on time due to non-conduction of examination, it was ordered that in the case of senior employees who have passed the next departmental examination and are otherwise qualified, the senior employees can be promoted with effect from the date of promotion of the junior employees by relaxing Rule 28 b (iA), 28 (bb) of KS & SSR Part –II if the junior has been promoted over the senior with only notional financial benefit for that period. Accordingly applications were invited on the subject matter vide ref read as 6th above. One application and connected documents was received from Sri Dinesh VS, Senior Clerk of 23 (K) Bn NCC.

3. On detailed examination, It is learned that Sri.Dinesh VS, Senior Clerk who is one among promotees included in the promotion of Senior Clerk published vide this Directorate proceedings read as 3rd paper above is an employee who has lost his seniority due to non-conducting of examination in the context of covid-19 in the year of January 2020 and January 2021. Individual had applied for the examination in the month of January 2020 but due to the non-conducting of examination, individual again applied in the month of July 2020 and qualified in the month of July 2020. Hence the individual is eligible for protection of seniority as per GO read as 4th paper above and promotion order issued vide this Directorate proceedings 3rd paper above is required to be modified.

4. The promotion order in respect of Serial No.41 to 57 at para 4 (b) of the proceedings cited 3rd above is revised and modified only to this extent.

8. Sri.Dinesh V S (PEN 838679) Sr.Clerk, 23(K) Bn NCC, whose date of promotion is modified will be eligible only for notional financial benefit for the period from 23.06.2020 to 01.04.2021.
