8. Those who have been detailed for upcoming Loksabha Election duties, should perform their duties as detailed.

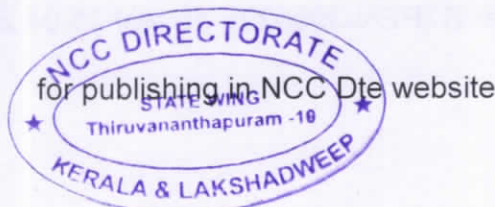


