ORDER

1. As per the proceedings read as 3rd paper above, the promotion of Sri. Sujith S (PEN: 896908), Lascar Grade-II of the 3(K) Naval Unit NCC, Kollam and Sri. Vinod Kumar T K (PEN: 848426), Lascar Grade-II of the 5(K) Girls Bn NCC, Changanacherry to the post of Lascar Grade-I was not considered due to the non-declaration of their probation. Consequently 02 vacancies were set aside for their promotion. The probation of Sri. Sujith S (PEN: 896908), Lascar Grade-II, was declared wef 09.10.2021 vide order read as 4th paper above. However, probation of Sri. Vinod Kumar T K (PEN: 848426), Lascar Grade-II of 5(K) Girls Bn NCC, Changanacherry is still pending due to the non receipt of a suitability report from the Police authorities. Therefore, the promotion of Sri. Sujith S (PEN: 896908), Lascar Grade-II is now being considered against the vacancy reserved vide the proceedings cited 3rd above.

As per the provision contained in the GO read as the 1st paper above and in continuation of this Directorate proceedings read as 3rd paper above, the following Grade – II Last Grade Servants are promoted to Grade – I in the pay scale of Rs. 23700-52600/- (revised), against the vacancies arose wef the date shown against their names in the ratio of 2:1.
