APPEAL RECEIVED AND REASON FOR CONSIDER/NOT CONSIDERATION

S.No	Name & Designation	Present Office	Reason
1.	Smt Leena G, Manager	NCC Gp HQ, Kozhikode	The officer has completed more than 10 years of service at the present/home station and spark system has been accepted the transfer application of Smt Raji P, Manager of Gp HQ, Ernakulam who has 1691 days of outstation service.
2.	Sri Sivakumar KV, Junior Supdt	30 (K) Bn NCC, Kozhikode	Individual has opted only one station in the online application for General transfer. According to the potential vacancy list generated by spark, 18 (K) Bn NCC, Junior Supdt vacancy is shown as "replacement". However SPARK system has not chosen to transfer him to a particular office and his outstation service and length of service at present station may not be sufficient to consider him for replacement.
3.	Smt Jayalekshmi L, Junior Supdt	NCC Gp HQ, Ernakulam	Individual requested that the application for transfer should not be considered as she is now suffering from serious illness and is being treated at Aster Medicity, Kochi. Her application is considered on humanitarian ground.

Sri Manu P Jayan, Junior Supdt	27 (K) Bn NCC, Palakkad	<p>Individual requested to posting 14 Kerala Bn NCC and 15 Kerala Bn NCC as his mother is chronic case of severe survival spondylosis and other old age diseases required constant medical care. His wife is employed as VHSE teacher in Pathanamthitta Dist.</p> <p>Considering the above reasons and Sri Anil Kumar MP, Junior Supdt of 9 (K) Bn NCC has already applied and availed last leg posting to the present unit (9 (K) Bn NCC, Kottarakara) last year. Now the HOD has recommended his transfer to 3 (K) NU NCC on administrative reasons.</p> <p>Therefore the application of Sri Manu P Jayan is being considered for 14 (K) Bn NCC.</p>

Sri Bineesh B Chandran Junior Supdt	29 (K) Bn NCC, Thenjipalam	Individual requested to consider his application for transfer to 15 Kerala Bn NCC and 14 Kerala Bn NCC as his mother aged 73 years is in treatment for many aged related disease and wife is also suffering from serious illness after premature delivery of his son and his application is being considered favorably on humanitarian ground against the vacancy aroused due to the cancellation of posting request of Smt Jayalekshmy JS, NCC Gp HQ, Ernakulam.
