**ORDER**

1. Two vacancy of Junior Superintendent and two vacancy of Head Clerk are held in this department sine 01/02/2024 against the retirement as shown below:-

2. At the same time Sri. Shaji R, Senior Clerk, NCC Directorate has filed an OA 131/2024 before the Hon'ble KAT to restrain CES employees of this department of the OA from effecting promotions of supervisory posts in the NCC Department beginning from the post of Head Clerk to Senior Superintendent (HG). On this, the Hon'ble KAT vide order cited 3<sup>rd</sup> above has ordered that promotions if any granted to the party respondents will be subject to the outcome of the Original Application and thereby this department needed clarification from Government for issuing promotions on the existing JS/HC vacancies. So, vide letter cited 4<sup>th</sup> above, this department has asked clarification from Government that , if there is any legal complications or restriction on implementing promotion from the existing seniority list. The reply from the Government is still awaited.

In such circumstances, for avoiding administrative problems within the department due to the non availability of Junior Superintendent as well as DDOs, it is decided to consider the transfer requests submitted by the Junior Superintendent of this department on various grounds. After scrutinizing the transfer applications, the following transfer/posting are ordered in the cadre of Junior Superintendent with immediate effect:-
