ORDER

1. Govt has sanctioned transfer the following posts temporarily from various NCC Gp HQs/ units to 5(K) Bn NCC, Manathavadi till the shifted posts are filled up by KPSC District office Wayanad vide GO read as 3rd paper above.

2. This Directorate has ordered temporary transfer of posts to 5 (K) Bn NCC, Wayanad vide reference read as 4th paper above. In view of the delay in making appointments through KPSC to these posts so far shifted to 5 (K) BN NCC, Wayanad, the following employees are ordered to be transferred to the temporarily shifted posts at 5(K) Bn NCC, Wayanad with immediate effect for smooth and efficient functioning of the battalion.

The Govt vide reference cited 7th paper above has dismissed the appeal filed by Sri.Shabithlal KP, JR.Supdt (HG), NCC GP HQ Kozhikode vide ref read 6th paper above challenging the NCC Dte order in which he transferred to 1(K) R & V Sqn, NCC and subsequently re-deployed to 5(K) Bn NCC. The Govt also ratified the action taken by the Directorate to transfer him to 1 (K) R & V Sqn NCC and subsequently redeploy to 5 (K) Bn NCC. In order to comply with the Govt instructions, this Directorate has issued order directing Sri. Shabithlal KP, JR.Supdt (HG), NCC GP HQ to join at 5(K) Bn NCC on or before 28 Feb 2024 vide reference 8th paper above.

4. Sri. Shabithlal KP, JR.Suptd (HG), NCC GP HQ is hereby directed to take charge as DDO of 5 (K) Bn NCC to initiate necessary action for drawing and disbursement of pay and allowances through SPARK to the employees appointed to temporarily shifted posts in 5 (K) Bn NCC.
5. It is hereby ordered that, Sri.Sajeev Kumar T, Clerk be reverted from redeployment and posted to 7(K) BN NCC, Kollam in the existing vacancy when Sri. Sreejith KP, Sr.Clerk, 9(K) NU NCC join at 5 (K) BN NCC, Wayanad.
6. Sri.Koya. K, OA Gr-II of NCC Dte (K&L) currently re-deployed in 5(K) Bn NCC, will continue as OA in temporarily shifted post in 5(K) Bn NCC Bn, Wayanad.
7. The above mentioned employees are directed to report before the Commanding Officer, 5(K) Bn NCC, Manathavadi, Wayanad with immediate effect.
8. The Head of Office of the respective NCC Offices are hereby directed to make necessary arrangement to relieve the above mentioned staff so as to enable them to report to the Commanding Officer, 5(K) Bn NCC, Wayanad.


