**ORDER**

- 1 . Sri. Subash S, Clerk of 28 (K) Bn NCC, Ottappalam, has requested transfer on extreme compassionate grounds in connection with the ongoing treatment of his wife. He will take seniority as the junior-most in Alappuzha District in accordance with Rule 27(a), Proviso 1 of the Kerala State & Subordinate Service Rules, 1958. Necessary entry to this effect shall be made in the Service Book of the incumbent under proper attestation.
4. Head of Officers are requested to download the order from the website and hand over one copy to the employee concerned. The actual date of joining/relieving should be reported immediately to this Directorate. The relieving of incumbent should be cleared by the respective Head of Office.
5. Necessary entry will be made in the service book of the incumbent under proper attestation. TA/DA/Joining Time admissible as per existing rules
