Sub: NCC Dept- Est – Online General Transfer of Employees – Draft online General Transfer order-2025 through SPARK – Publication Regarding.

1. As per government order cited as reference 1, revised norms and guidelines have been issued regarding the general transfer of State Government employees. Further, reference 2 contains strict instructions to implement general transfers of employees through the online system.

2. In compliance with the above, this Directorate issued detailed instructions (reference 3) inviting eligible employees to apply online through the SPARK system. The last date for forwarding applications to the State Level Officer by the Head of Office through SPARK was fixed as 21.04.2025.

3. Applications received through SPARK for the Online General Transfer 2025 have been processed and the draft report has been appended herewith. All Heads of Office are requested to download the circular from the website and distribute copies to the concerned employees.

4. The proposed transfer of Sri. Manoj R, Clerk, 1 (K) NU NCC, Aakulam to the NCC Directorate, Thiruvananthapuram, will not be considered. As per policy, all clerical (LD Clerk) vacancies in the NCC Directorate are classified as Headquarters vacancies. Hence, transfer under SI No. 01 and 04 in the draft General Transfer list (Clerks) will not be implemented.

5. Any representations if any should reach this Directorate on or before 07 May 2025. Belated requests will not be considered under any circumstances and the list will be finalized accordingly. Representations may also be e-mailed to nccjsest@gmail.com.
