ORDER

1. The Hon'ble Kerala Administrative Tribunal, in its Judgement cited as 3rd above, in OA No. 924/2025 filed by Sri. Babinton S, Senior Grade Driver, 4 (K) Bn NCC, Neyyattinkara, directed the Government to consider and pass appropriate orders on the applicant's appeal after affording him an opportunity of being heard, within two months.
2. Accordingly, this Department re-examined the case and, vide 6th paper read above, reported that the applicant may be considered for transfer to 7 (K) Bn NCC, Kollam. It was further proposed that, Sri. Sunil Kumar S, Senior Grade Driver presently at 7 (K) Bn NCC, Kollam, may be transferred to 9 (K) Bn NCC, Kottarakkara, against the existing vacancy.
3. The Government, after hearing both the applicant and this Department, and as per G.O read 7th paper above, directed this Directorate to transfer Sri. Babinton S to an NCC Unit located in Varkala or to offices within Kollam District, so as to enable him to discharge his duties as Driver efficiently.
