ORDER

1. In the GO read as 1st above, Govt had accorded approval in principle for raising of new NCC Unit at Mananthavadi, Waynad and vide GO read as 2nd paper above sanction has accorded to re-deploy the staff as mentioned below from any NCC Units for newly raised NCC Unit 5 (K) Bn NCC, Mananthavadi till posts are sanctioned by the State Government.

2. Sri Baburaj TK, Clerk of 30 (K) Bn NCC who was re-deployed earlier to 5 (K) Bn NCC read as 6th above has requested to cancel his re-deployment to 5 (K) Bn NCC on compassionate ground vide representation read 8th paper above. Sri Sathyanathan K, (PEN 500749) Clerk of NCC Group Headquarters, Ernakulam has expressed his willingness for re-deployment to 5 (K) Bn NCC Mananthavadi as per 5th paper above and Sri Ranjith Kumar KM, LDT (PEN 791913) and Sri Koya K, OA (PEN 725899) of this Directorate those who have already been re-deployed at 5 (K) Bn NCC vide proceeding read as 4th paper above has also requested to extend the period of their re-deployment for a further period of one year as per letter read as 3rd and 7th paper above.

3. In the above circumstances, the undersigned has examined the matter in detail and ordered to re-deploy Sri Sathyanadhan K, Clerk (PEN500749) NCC Group Headquarters, Ernakulam to 5 (K) Bn NCC for a period of one year or till the new post is created by Govt whichever is earlier . The re-deployment of Sri Ranjith Kumar KM, LD Typist and Sri Koya K, Office Attendant, NCC Directorate Thiruvananthapuram ordered as per proceeding read as 4th paper above is also extended for further period of one year.



4. Sri Sathanadhan K, Clerk of NCC Group Headquarters Ernakulam is directed to report to the Commanding Officer 5 (K) Bn NCC , Wayanad with immediate effect.
5. Re-deployment of Sri Baburaj TK, Clerk 30 (K) Bn NCC to 5 (K) Bn NCC as per proceedings read 6th paper above is hereby cancelled.
6. Necessary arrangements are to be made by the units concerned to relieve/retain the said incumbents with immediate effect. The details of relieve/retain should be informed to this Directorate.
7. The pay and allowances of the re-deployed employee should be drawn and distributed from his parent Office. The re-deployment of civilian staff as mentioned in this order is limited for a period of 12 months from the date of joining at 5 (K) Bn NCC, Wayanad or new post is sanctioned by the Govt whichever is earlier.


