ORDER

1. One vacancy to the post of Ship Modelling Mechanic arose in 9(K) Naval Unit NCC, Kozhikode due to the LPR of Sri Mohanan P, SMM in 9(K) Naval Unit NCC, Kozhikode. In order to fill up the said vacancy through "by transfer", applications were invited from eligible lower category employees having requisite qualifications as per this Directorate letter read as 1st paper above and accordingly five applications were received in this Directorate.

2. As such a Board of Officers was constituted with CO, 9 (K) Naval Unit NCC, Kozhikode as Presiding Officer, Manager NCC, GP HQ, Kozhikode & SMM 5(K) NU NCC, Changanacherry as members 1&2 for finding suitability of the candidates vide this Directorate letter read as 2nd paper above. The CO, 9 (K) NU NCC as per letter read as 3rd paper above has submitted the suitability report as agreed to by the Board and recommended the following candidates as found suitable.

The proposal was examined in detail, According to the provisions in KS&SSR part II Rules 28 "promotions or appointments 'by transfer' to higher posts shall, subject to the provisions of these rules, and the special rules, be made in accordance with seniority subject to the person being considered suitable for the post". Therefore the senior most among the candidates **PEN 866007 Sri. Sunny Thomas, AMH of 1(K) Air Sqn NCC, Thiruvananthapuram** is found suitable and hence is appointed "by transfer" as **Ship Modelling Mechanic** in the scale of pay of **Rs 25200-54000 (Revised Rs 35600-75400/-)** and posted to **9 (K) Naval Unit NCC, Kozhikode** in the existing vacancy.

The promoted incumbent will be on probation in the cadre of Ship Modeling Mechanic for a period of two years on duty within a continuous period of three years from the date of assuming duty as SMM. Necessary entries will be made in the service book of the incumbent regarding promotion under proper attestation. The date of joining duty as SMM will be reported to this Directorate by the unit concerned promptly.
