1. The various rules regarding By-transfer appointment from Low Paid Employees to the post of LDC have been enumerated in the G.Os and letters read as 1 to 6 paper above.
2. Consequent to the retirement of Sri. Viswambharan N V, (PEN – 385225), Clerk of 28 (K) Bn NCC on 30 Apr 2023 appointed under 'by transfer' appointment to the post of Clerk from among the low paid employees, Sri. Prasanthan P, (PEN-707709), Dvr Sr Grade of 1 (K) Arty Bty NCC, Thalassery, the senior most employee in the seniority list was ordered to be posted on "By Transfer" appointment to 28 (K) Bn NCC, Ottappalam vide this Directorate Proceedings read as 7<sup>th</sup> above.
3. But, Sri. Prasanthan P has submitted his statement of relinquishment of promotion for a period of one year vide ref cited 9<sup>th</sup> paper above. The matter was examined in detail and the request for relinquishment of Sri. Prasanthan P is hereby accepted.

4. In the circumstances, Sri. Sivan Thekkan (PEN-432477), Lascar Grade I of 32 (K) Bn NCC, Payyannur being the next eligible senior most person is hereby appointed as Clerk under by transfer appointment from Low paid employees in the scale of pay of Rs. 26500-60700/- and is posted to 28 (K) Bn NCC, Ottappalam against the retirement vacancy of Sri. Viswambharan N V, (PEN – 385225), Clerk of 28 (K) Bn NCC on 30 Apr 2023.

5. He will be on probation in the cadre of Clerk for a period of two years on duty within a continuous period of three years from the date of joining of duty as Clerk vide para 4 (I) of GO (P) No 17/2018/P&ARD dated 27 Dec 2018.

6. The Original educational qualification certificates should be verified by the Head of Office of respective Group HQ/Unit to where the individual is being posted. The incumbent, if not willing to join duty as clerk should submit the unwillingness to this Directorate through proper channel within 10 days from the date of receipt of this order.

7. Necessary entries will be made in the Service Book of the incumbent under proper attestation and the date of joining duty should be intimated. The head of Office is requested to relieve the above employee so as to enable him to join the duty in the appointed post of Clerk in the scale of pay of Rs. 26500-60700.
