**ORDER**

1. The various rules regarding 'By-transfer' appointment from Low Paid Employees to the post of LDC have been enumerated in the G.Os and letters read as 1 to 6 paper above.
2. Consequent to the retirement of Sri. Viswambharan N V, (PEN – 385225), Clerk of 28 (K) Bn NCC on 30 Apr 2023 appointed under 'by transfer' appointment to the post of Clerk from among the low paid employees, one vacancy of Clerk has arisen at Kozhikode region, the following senior most employees in the seniority list of Low Paid Employees are submitted their statement of relinquishment of appointment as Clerk for a period of one year as per the details mentioned below and the matter was examined in detail and their request for relinquishment was accepted :-

3. At the same time, the next senior most eligible candidate in the seniority list vide this Directorate Proceedings read as 7<sup>th</sup> paper above is Sri. Marakkur TP (PEN-446570), Office Attendant Grade-I who was also in the seniority list of Typist had promoted as LDT vide this Directorate proceedings No 0694/A2-III/Est/2021/NCC dated 26 May 2022 and posted at NCC Group HQ, Kollam. The next senior Sri. Jayachandran KC (PEN-455270), Lascar Gde I has also retired from service on 30 Jun 2021.

4. In the circumstances, Sri. Sudhakaran C (PEN-508726), Lascar Grade I of 30 (K) Bn NCC, Kozhikode being the next eligible senior most employee in the list is hereby accorded 'By Transfer' appointment as Clerk in the scale of pay of Rs. 26500-60700/- and is posted to 28 Kerala Bn NCC, Ottappalam against the retirement vacancy of Sri. 5. He will be on probation in the cadre of Clerk for a period of two years on duty within a continuous period of three years from the date of joining of duty as Clerk vide para 4 (I) of GO (P) No 17/2018/P&ARD dated 27 Dec 2018.

6. The Original educational qualification certificates should be verified by the Head of Office of respective Group HQ/Unit to where the individual is being posted. The incumbent, if not willing to join duty as clerk should submit the unwillingness to this Directorate through proper channel within 10 days from the date of receipt of this order.

7. Necessary entries will be made in the Service Book of the incumbent under proper attestation and the date of joining duty should be intimated. The head of Office is requested to relieve the above employee so as to enable him to join the duty in the appointed post of Clerk in the scale of pay of Rs. 26500-60700.


