1. The various rules regarding 'by transfer' appointment from Low Paid Employees to the post of LDC have been enumerated in the G.Os and letters read as 1 to 6 and 8 paper above.

This Directorate published seniority list for appointment of LPE 10% by transfer promotion to the eligible senior most Low Paid Employees to the post of clerk in the reserved vacancies vide this Directorate order read as 7th paper above. Among them under Kollam region, at present 02 vacancies have been arisen due to the retirement of Sri. Anil Kumar D, (PEN – 678689), Clerk of 10 (K) Bn NCC and Sri Anil Kumar D (PEN – 706983), Clerk of 11 (K) Bn NCC on **31** May 2023 who were appointed as Clerk under 'by transfer' from Low Paid employees.

In the circumstances, the following senior most low paid employees in the existing regional wise final seniority list published vide ref read as 7th above are provisionally appointed as Clerk through ' by transfer' appointment method in the scale of pay of Rs. 26500-60700/- and are posted to the offices shown against their names in the existing vacancies :-

They will be on probation in the cadre of Clerk for a period of two years on duty within a continuous period of three years from the date of joining of duty as Clerk vide para 4 (I) of GO (P) No 17/2018/P&ARD dated 27 Dec 2018. The individuals who have less than two years of service to retire are appointed as Clerk provisionally on condition that, the above appointments made under 'by transfer' will be finalized subject to clarification from Govt on whether they should pass the mandatory test of MOP before retirement, as insisted in the GO referred as 8th above.

5. The Original educational qualification certificates should be verified by the Head of Office of respective Group HQ/Unit to where the individuals are being posted. The incumbents, if not willing to join duty as clerk should submit the unwillingness to this Directorate through proper channel within 10 days from the date of receipt of this order.

6. Necessary entries will be made in the Service Book of the incumbent under proper attestation and the date of joining duty should be intimated. The head of Office is requested to relieve the above employee forthwith so as to enable him to join the duty in the appointed post of Clerk in the scale of pay of Rs. 26500-60700.
