**ORDER**

Government as per order read as 3<sup>rd</sup> paper above has accorded sanction for the appointment of the following candidates as Lower Division Clerk in the Supernumerary posts created as per Order read as 2<sup>nd</sup> paper above in the Districts mentioned against their names in the scale of pay of Rs. 19000-43600/- under **Compassionate Employment Scheme**. Thereafter, Government as per letter read as 4<sup>th</sup> paper above has forwarded a copy of Court direction dated 25.02.2016 in WP(C) No. 33621/2015 & 5960/2016 directing not to create any supernumerary post for making any appointment or regularization of Compassionate appointees, for strict compliance. Therefore, this Directorate has not issued any orders for appointing the 07 incumbents in this Department under Compassionate Employment Scheme and requested further directions from Government in this regard.

Government as per letter read as 5<sup>th</sup> paper above has directed to issue orders appointing 07 incumbents in this Department under **Compassionate Employment Scheme**, whose appointment was with held based on the orders of Hon'ble High Court of Kerala direction dated 25.02.2016 in WP(C) No. 33621/2015 & 5960/2016. 3. They are directed to report before the Commanding Officer of the unit concerned within 15 days on receipt of this proceedings with necessary documents in original to prove their date of birth, educational qualification, Identification Certificate of the individual as per Proforma enclosed after affixing a passport size photograph recently taken and duly attested by a Gazetted Officer in the Government Service. They are also required to produce a Medical Fitness Certificate in original from a Medical Officer not below the rank of an Assistant Surgeon having MBBS degree, failing which he will not be admitted for duty. As per GO (P) No. 20/2011/P&ARD dated 30.06.2011, the candidates are also directed to affix their thumb impression on the medical fitness certificate along with an attested copy of photograph.

4. The appointment of the candidates are temporary under Rule 9 (a) (i) of the General Rules of the Kerala State and Subordinate Service Rules 1958 as provided in the rule 10(b) of the above Rules and also subject to satisfactory report in Police verification later regarding their character and antecedents. The service of the individuals are also subject to Rule 3 (c) of the General Rules of the Kerala State and Subordinate Service Rules 1958.

5. The Employment Assistance ordered under the scheme will be cancelled if and when Government find any suppression or misrepresentation of material facts on the part of the applicant at the time of forwarding application or during the course of enquiry conducted by the District Collector and also if it is proved on examination that the orders were erroneously issued.
6. The details of appointment will be entered in the Service Book of the deceased employees concerned and in the establishment registers of the Office in which the deceased employees last worked and should be attested by the competent authority concerned.
7. They will be on probation in the cadre of **Clerk** for a period of two years on duty within a continuous period of three years from the date of their joining duty during which they have to pass the departmental test of MOP. All relevant conditions laid down in the GOs also applicable to this appointment.
8. The Head of office will obtain the Police verification proforma (available in NCC website) duly filled in by the candidates before they are allowed to join duty and forward to this Directorate for further necessary action. The date of joining duty should be reported promptly. Service book in respect of the individuals may be opened within one week from date of joining duty. As per Government circular No. 20/2003/Fin dated 03 Feb 2003, the details regarding the quota in which the candidate is appointed should be recorded in their service book.
9. The Head of Office will obtain and submit application for allotment of **Permanent Retirement Account Number (PRAN)** to concerned Treasury from the individual vide GO(P) No. 49/2013/Fin dated 03.04.2013.
