**ORDER**

1. Two vacancies of Attender Grade-II by transfer promotion from LGS are existing in this department due to the retirement of Sri. Mohanan P, Attender Gr-I, NCC Group Headquarters, Kottayam and Sri. Ratheesh Kumar N, Attender Grade - I, NCC Group Headquarters, Thiruvananthapuram respectively. Consequently this Directorate vide letter read as 3<sup>rd</sup> paper above have invited applications from the eligible Last Grade Servants of this Department for appointment as Attender Gde-II (Non-Technical) by promotion from Last Grade Servants in the vacancies existing at NCC Group Headquarters, Kottayam and NCC Group Headquarters, Thiruvananthapuram.

As per above, 06 applications for the vacancy in NCC Group Headquarters, Thiruvananthapuram, and 01 application for the vacancy in NCC Group Headquarters, Kottayam have been received up to 09 Aug 2019 (Last date of receipt of application). The applications have been scrutinized thoroughly and PEN 669661 Sri. Jayakumar B, Lascar Gr-I, 2 (K) BN NCC, Thirumala, (seniority No.106) being the senior most with requisite qualifications found eligible among the candidates applied for appointment to the post of Attender Grade-II, in NCC Group Headquarters, Thiruvananthapuram and PEN 723753 Sri Shaji M George, Lascar Gr-II, NCC Group Headquarters, Kottayam (seniority No 160) is found eligible with requisite qualifications for appointment to the post of Attender Grade-II, in NCC Group Headquarters, Kottayam. Sri. Satheesh Kumar P, Chowkidar Gr-II, 3(K) BN NCC (seniority No 129) Sri. Suresh Kumar B Lascar Gr-II, 3(K) BN NCC (seniority No 131) and Sri.
