ORDER

1. In the GO read as 1st above, Govt had accorded approval in principle for raising of new NCC Unit at Mananthavadi, Waynad and vide GO cited 2nd accorded sanction to re-deploy the staff as mentioned below from any NCC Units for newly raised NCC Unit 5 (K) Bn NCC, Mananthavadi till posts are sanctioned by the State Government.

This Directorate vide letter cited 3rd above called for volunteers for the above posts but no employees (Clerks/Typists) have expressed their willingness for re-deployment to the newly raising Unit at Waynad. Three applications have been received through NCC Group Headquarters Kozhikode from which 1 UDT and 1 LDT have requested to revert them from 5(K) BN NCC to their parent unit and 1 Lascar Grade- II has requested to retain him with 5(K) BN NCC for another 12 months. One application has been also received from OA Grade II of 17 (K) BN NCC through NCC Group Headquarters Kottayam has requested to consider him for redeployment in 5(K) BN NCC.

3. In the above circumstances, the undersigned has examined the matter in detail and ordered to re deploy the following junior most staff from various NCC Offices as indicated below for a period of one year or till the new posts is sanctioned by the State Government whichever is earlier.

The Head of Office of the respective NCC Offices are hereby directed to make necessary arrangements to relieve the above mentioned staffs so as to enable them to report to the Commanding Officer, 5(K) BN NCC, Kalpetta without fail. PEN - 807096, Sri. Vinod Kumar U, UDT and PEN - 791913 Sri. Ranjit Kumar KM, LDT will be returned to their parent units after the joining of the above said incumbents in 5(K) BN NCC. PEN - 723039 Sri Jose PD Lascar Grade -II is hereby permitted to continue the re - deployment for further one year in 5(K) BN NCC vide considering his request. The application of Sri Vijayan TK Lascar Grade -II of 17(K) Bn NCC cannot be accommodated due to no vacancy of OA is existing at present at 5(K) BN NCC for deployment.

6. The pay and allowances of the re-deployed employees should be drawn and distributed from their parent offices. The redeployment of civilian staffs as mentioned in this order is limited for a period of 12 months from the date of joining at 5 (K) Bn NCC, Kalpetta, Wayanad.
