ORDER

1. The Commanding Officer 7(K) Naval Unit Ernakulam vide letter read 1st above has reported misbehaviour/misconduct of Sri. Sivadas K V (PEN-983898), Lascar Grade-II on 21.08.2024, which had led to manhandling, disruption of office work and filing FIR against the delinquent vide ref cited 2nd above. This report summarizes the series of incidents involving Sri.Sivadasan K V (PEN-983898), Lascar Grade-II, highlighting his abnormal behaviour, misconduct and safety concern. The report also reveals that the individual’s behaviour has been deemed significant threat to staff safety and unit morale as evidenced by recurring incidents of misconduct and verbal abuse against colleagues.

2. Based on the above incident, the commanding officer 7(K) NU NCC has served a memorandum dated 19.08.2024 to the individual citing the reason mentioned above and additionally a complaint was lodged at police station Thevara, Ernakulam regarding the incident. The individual’s behaviour as observed and reported by the Commanding Officer 7(K) NU NCC exhibits potentially harmful tendencies, necessitating immediate attention and intervention. The Commanding Officer, the Head of Office also strongly recommended that, “the individual be considered unfit for any job”.

3. in view of the above incidents and the report and the recommendation of Head of office the individual can’t be allowed to continue in the same office, Which will endanger the lives of the employees and also affect the peaceful atmosphere of the office. Considering the above facts Sri. Sivadas K V (PEN-983898), Lascar Grade-II, 7(K) Naval Unit Ernakulam is hereby suspended from service with immediate effect as

per Rule 10 of KCS & CCA Rule 1960, pending further investigation and disciplinary proceedings for his reported misconduct/misbehaviour in office.


