**ORDER**

1. The Group commander NCC Group Headquarters Kollam vide their letter read 1<sup>st</sup> to 3<sup>rd</sup> above has been reported a disciplinary case against Sri. Venugopalan Pillai R, (PEN-805348) Senior Grade Driver of 9 Kerala Bn NCC for following lapse and asking for immediate disciplinary action:-

- a) Serious insubordination.
- b) Intimidating and attempting to manhandling a colleague at work place.
- c) Disrupting office work
- d) Making derogatory comments about Lt Col Vinod Kumar Administrative Officer 9 Kerala Bn NCC on social media and instigating other office staff against the officer by propagating false allegations.

2. On the basis of the above report, a preliminary inquiry was ordered vide reference cited 4<sup>th</sup> above to ascertain the status of the allegations against Sri, Venugopalan Pillai R, (PEN-805348) Senior Grade Driver of 9 Kerala Bn NCC. The inquiry report has<sup>been</sup> received vide reference cited 5<sup>th</sup> above. The allegations against him have been confirmed in the preliminary inquiry report. The inquiry report states that he had committed similar types of misconduct in the past and needs to be dealt properly.

3. Based on the findings in the preliminary inquiry report the suspension of Sri. Venugopalan Pillai R, (PEN-805348) Senior Grade Driver of 9 Kerala Bn NCC from service has been considered necessary in public interest in order to maintain proper discipline and harmony in the office and to conduct a proper detailed inquiry against him.

4. In view of the above, Sri, Venugopalan Pillai R, (PEN-805348) Driver Senior Grade of 9 Kerala Bn NCC, Kottarakkara is hereby suspended from service with immediate effect pending disciplinary proceedings as per rule 10 (a) & (c) of KCS & CCA Rules 1960.

5. Sri, Venugopalan Pillai R, (PEN-805348) Driver Senior Grade of 9 Kerala Bn NCC will be paid subsistence allowance as per the existing rules. Necessary entries should be made in the service book/e-service book of the individual. The receipt of this order may be acknowledged.
