ORDER

1. As per GO read as 1st above, Government reserved 10% of vacancies of LDC/LD Typist of any department for the eligible employees of Last Grade Servants of that Department. The GO read 2nd above was issued to give more clarity to the 1st GO regarding cadre strength, date of effect of order etc. As per the GO read as 3rd above, Government ordered to reserve 10% vacancy to be set apart for 'by transfer' appointment from low paid employees from State wide vacancies, if it cannot be set apart district wise. As per GO read as 5th paper above, Government have rescinded the conditions at para 2 (ii) in GO read as 2nd paper above. Government vide letter read as 6th paper above directed to implement the GO read as 1st paper above, and actions must be taken as described in the GO read as 2, 3 & 4th above. The matter has analysed in detail and this office has fixed cadre strength for the post of LD Typist State wide vide proceedings read as 7th paper above.

2. Further vide letter read as 10th paper above, Government clarified that the lower category employees who were promoted to higher scale of pay than LDC/LDT can also be considered for 'by transfer' appointment as Clerk/Typist from low pay scale employees.

3. Accordingly, this Office had invited applications for by transfer appointment to the post of LD Typist from the low paid employees vide letter read as 13th paper above. Only one application received for the post of LDT and found not eligible to include in the provisional seniority List. As such the provisional seniority list of employees was published vide letter read as 14th paper above.

4. Since no observations have been received from various Units/Gp HQs, following decision is taken with respect to the Provisional seniority list published vide letter read as 14th paper above.

5. As per this office proceedings read as 11th and 12th paper above Sri Santhosh S of NCC Gp HQ Kollam and Sri. Suresh Kumar B of 3(K) Bn NCC were appointed to the post of LD Typist through by transfer method from LPE. Thus the cadre strength to the post of LDT from low paid employees, cited 7th paper above has been filled. The next by transfer appointment will be made as and when vacancy arise in this cadre.

6. The Seniority List is now finalized and added as "Appendix- A" to this proceedings, which is being published through a Gazette Notification..
