ORDER

1. This Directorate had published seniority list of clerks of this department as on 12.08.2016 and 11.06.2018 vide ref 1st and 2nd above respectively. 9 (K) Girls Bn NCC vide ref 4th above brought to notice an anomaly in the seniority list published vide ref 3rd above regarding the seniority of Sri. Sudheer Kaliyedath (SI No 51) and Sri Sahad MP (SI No 50). On scrutiny, the PSC advice date erroneously mentioned in the ref 1st and 2nd seniority list in respect of Sri Wilson T and Sri Sahad MP as 09.04.2014 instead of 04.09.2014. As a result, Sri Sudheer Kaliyedath and Sri Hussain KK were placed below the seniority position of Sri Wilson T and Sri Sahad MP. Vide the ref cited 5th this matter has been communicated with the incumbents concerned with direction to bring into notice any observation/query in this matter with relevant documents to substantiate such claim positively by 21 Sep 2023 and objection/observation received thereafter would not be entertained. However, no such observation/objection received till date.

Hence, the matter has been examined in detail and the undersigned is hereby issued necessary amendment in the seniority position of following Clerks, which was erroneously entered in the final seniority list of clerks published vide reference cited 1st and 2nd above as follows.
