ORDER

1. Sri Thulaseedharan Nair G, previously an OA Gde I at 9 (K) Bn NCC, Kottarakara was promoted 'By Transfer' under the 10% LPE quota to the post of Clerk and posted to 8 (K) Bn NCC, Mavelikkara as per the directorate proceedings read as 4th paper cited above. Since both units fall under Kollam region and his transfer was considered a regional reassignment. Subsequently the incumbent applied for an inter-district transfer on extreme compassionate ground. As per the Govt Order reference 5th paper cited above he was transferred to 9 (K) Bn NCC Kottarakara fill an existing general vacancy under Rule 27 (a) proviso 1 of KS & SSR. This was formalized through the directorate proceedings read as 6th paper cited above. He joined 9 (K) Bn NCC, Kottarakara on 04.07.2022. Accordingly, his seniority in the clerical cadre effective from 01 Jan 2024 was determined based on the date of his joining the new unit as per the directorate proceedings cited 8th paper above.

2. Later Sri Thulaseedharan Nair G submitted a representation requesting the protection of seniority lost due to his IDT. Upon verification as per the GO read as 9th paper above, both 8 (K) Bn NCC, Mavelikkara and 9 (K) Bn NCC, Kottarakkara fall within the Kollam region. Therefore, his transfer cannot be considered an inter-district transfer and his seniority has been restored. This directorate has communicated this matter to all units through official website vide reference 10th paper cited above, inviting observation/query with supporting documents to substantiate such claim by 21 Mar 2025. No observation/objection have been received till date.

3. Hence, the matter has been examined in detail and in light of the above findings necessary amendments to the final seniority list of Clerks, published vide reference cited 8th paper cited above have been issued as per the table below. Rest no changes :-


