**ORDER**

1. The various rules regarding by transfer promotion to the post of LDC/LDT have been enumerated in the G.O cited 1 to 3 above.
2. As per G.O cited 1<sup>st</sup> Government reserved 10% of vacancies of LDC/LDT of any department for the eligible employees of last grade servants of that department. The 2<sup>nd</sup> G.O cited above was issued to give more clarity to the 1<sup>st</sup> G.O regarding cadre strength, date of effect of order etc. As per the 3<sup>rd</sup> G.O cited, Government ordered to reserve the 10% vacancy to be set apart for by transfer promotion from LPE from state wide vacancies, if it cannot be set apart district wise.
3. Consequent to the retirement of Sri. Abdul Assess M of 16 (K) Bn NCC, Kottayam who was appointed under by transfer appointment to the post of LD Typist from among the low paid employees. The said vacancy has been filled by appointing of Sri. Rajasekharan P , Attender Gde-II of NCC Gp HQ, Kozhikode who is the senior most employee in the seniority list vide this directorate proceedings read as 5<sup>th</sup> above.
4. However Sri. Rajasekharan P has not yet joined promotion post at 16 (K) Bn NCC and a representation is received from him as referred 6<sup>th</sup> above. He has requested that he being a native of Palakkad District and facing of some domestic problem he was unable to take promotion till date. He has also request to consider in any existing vacancy under Kozhikode Group.

5. In view of the above at present one LDT vacancy arose wef 25 Jul 2019 due to the sudden demise of Sri. Babu K , SGT of 9 (K) Naval Unit, Kozhikode (Under NCC Gp HQ Kozhikode).

6. As such one LDT vacancy existing under Kozhikode district is now filled by the posting of Sri. Rajasekharan P, Attender Gde-II of NCC GP HQ, Kozhikode and posted in the existing vacancy at 30 (K) Bn NCC, Kozhikode.

6. The promoted incumbent will be on probation in the cadre of LDT for a period of two years on duty within a continuous period of three years from the date of assumption of duty as LDT and the promoted incumbent is required to exercise option as per GO (P) No.07/2016/Fin dated 20.01.2016.

7. **The original educational qualification certificates should be verified by the Head of the office of respective units to where individual is being posted.**

8. The earlier posting of Sri. Rajasekharan P, Attender Gde-II to 16 (K) Bn NCC vide proceeding cited 5<sup>th</sup> above is hereby cancelled.

9. Necessary entry will be made in the Service Book of the incumbent under proper attestation and date of joining duty should be intimated.
